Poston Attended White House Reception Honoring HHS Advisory Board Service

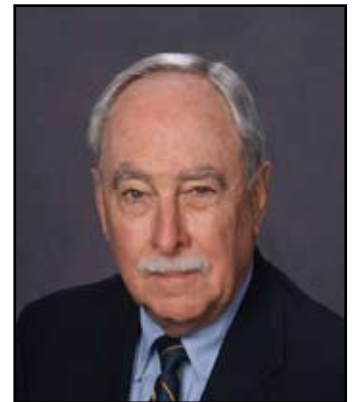

Dr. John Poston, professor of nuclear engineering and associate director of the Nuclear Power Institute at the Texas Engineering Experiment Station was in the White House rose garden on Tuesday, June 29. Poston and his colleagues on the Advisory Board on Radiation and Worker Health were among those invited to a reception hosted by President and Mrs. Obama honoring individuals who assist the government through service on advisory boards and commissions.

Poston was appointed to the board in 2006 by

President George W. Bush. He is the only Texan on the 14-member board, which advises the Secretary of Health and Human Services about the Energy Employees Occupational Illness Compensation Act (EEOIC). The act was passed in 2000, and it is implemented by the National Institute of Occupational Safety and Health (NIOSH).

The EEOIC law was passed to address the exposure of men and women engaged in building the nation's nuclear defenses to radiation and other hazards unique to

nuclear weapons and testing. The compensation program is designed to provide for

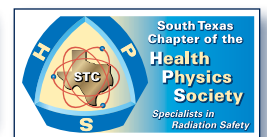

President-Elect's Report	Thank you to all of the local members who have helped put together the Student Presentation Meeting and thanks to John Salsman & Texas A&M Environmental Health & Safety for arranging the space for the EC meeting.	
Program Committee Report	The January 2010 meeting in Houston—Proton Therapy and visit from the HPS President-Elect Ed Maher—was a smashing success (even with the “rain” from the ceiling during lunch)! The meeting was very well attended, and we got to see a few faces we haven't seen in a while. The Proton Therapy Center staff provided a well-rounded and very informative program, complete with a behind-the-scenes tour of the facility. Kudos, again, to locals Jay Poston and Stan Bravenec for all of their hard work. The Chapter especially thanks the Proton Therapy Center staff who gave up their Saturday to enlighten us on the amazing work they are doing. Houston was a hard venue to have the meeting in, but it was worth bringing in new members.	
	Tomorrow's meeting is our Annual Chapter Business Meeting and Student Presentations. We have had 17 members pre-register and 12 students register to present—7 graduate students, 1 undergraduate, and 4 associate degree students. Judges will be needed for the presentations. Awards for top presentations will be awarded following the afternoon break. We have included a session at the end of the meeting for discussion about the upcoming Regulatory Conference (RegCon 2010).	
	The September 2010 meeting will be the Regulatory Conference. It will also serve as our Affiliate's Fair meeting. The Committee (STC, DSHS, TCEQ representatives) continue their work. Chapter members may be solicited for assistance as specific needs are identified. While there was some discussion about possible date changes for the conference, we have final confirmation that it will be held on the original dates—September 2 thru 4. We are looking at several possibilities for speakers. Pete Myers is working through his contacts to schedule them for our event.	
Treasurer's Report	There were two reimbursements that were voted on electronically by the EC and are reflected in the Secretary's Report. Motion to approve the reimbursement Motion: Karen Blanchard Second: Sam Daniel	<i>Committee Vote:</i> Approved
	The total assets of the Chapter are \$124,351.00 after an increase of \$3,392.99 due to membership dues, affiliate dues, scholarship donations, and teacher workshop donations. Motion to approve the Treasurer's Report Motion: John White Second: Karen Blanchard	<i>Committee Vote:</i> Approved
Treasurer-Elect's Report	Pete Myers did an excellent review of the STC-HPS budget management and determined that there are three significant sources of income in membership dues, donations, and investments. The

<p>Treasurer-Elect's Report <i>continued</i></p>	<p>individual membership has been declining over the past couple of years resulting in a decrease in income revenue. From the Treasurer's perspective, we should protect our resources so that we can increase our investments so that investment-payouts can help pay for future programs: Program Committee, Science Teacher Workshop, and Student Assistance Committee. The Program Committee has been losing money for the past two years, and the Student Assistance Committee and Science Teacher Workshop submit budgets in excess of their anticipated donations.</p>	
	<p>Three proposals were submitted regarding the fund balance trends:</p> <ol style="list-style-type: none"> 1) The Treasurer should prepare each next year's proposed budget in time to be distributed to the EC in December to be discussed and approved at the Chapter's January meeting. 2) The Chapter should not depend on dues and donations to provide funds adequate to resource its programs (e.g., Student Assistance and Science Teacher Workshop); investments must be increased to provide adequate and consistent funding. The EC, therefore, should approve the purchase of a second annuity ladder, paying out \$1,000 per year, for use either by the Student Assistance Committee or the Science Teacher Workshop Committee. <ol style="list-style-type: none"> a) The \$30,000 for the annuity ladder could come from: <ol style="list-style-type: none"> i) the Operating Fund ($\\$51,413.46 - \\$30,000 = \\$21,413.46$), or ii) \$20,000 could come from the Operating Fund ($\\$51,413.46 - \\$20,000 = \\$31,413.45$) and \$10,000 could come from either the Student Assistance Mutual Fund ($\\$14,722.67 - \\$10,000 = \\$4,722.67$) or the Science Teacher Workshop Fund ($\\$22,582.03 - \\$10,000 = \\$12,582.03$). b) If the \$1,000 were used by the Student Assistance Committee, it could be used to fund the second \$1,000 Educational Grant, and the committee's typical budget would be almost completely resourced with only a \$667 shortfall (i.e., Science Fair expenses), which could be provided from the Operating Fund. c) If the \$1,000 were used by the Science Teacher Workshop Committee, the second \$1,000 Educational Grant could be eliminated, and the Science Teacher Workshop Committee's annual deficit could be reduced from \$5,150 to \$4,150 (still a large deficit that must be addressed; see proposal 3.b.).

	The 2010 budget is a balanced budget due to the regulatory conference, otherwise the budget would be in the red. Questions arose regarding the report: <ul style="list-style-type: none"> 1. Why have we been okay for 20 years if we lose money each year? Answer: Regulatory Conferences and large donations to support the chapter. The concern is that the Regulatory Conference might not last long if the NRC revokes Agreement State Status and if the new management does not support the conference. 2. How can we turn around the support for the Regulatory Conference? Answer: Work with management and emphasize the need for the community. 	
	Discussion arose regarding the reason why each committee had large budgets submitted but in reality the actual cost spent on each committee is not close to the budgeted projection. Student Presentations at STC's April Meeting in College Station

Students from UT Health Science Center at San Antonio (UTHSCSA), Texas A&M Univ. (TAMU), and Texas State Technical College (TSTC) in Waco presented their research to attendees at the STC's Annual Student Presentations and Chapter Business Meeting held at the Zachry Engineering Building on the A&M Campus in College Station last April. Students vied for cash awards for the top two presentations in each category: Graduate, Undergraduate, and Associate. 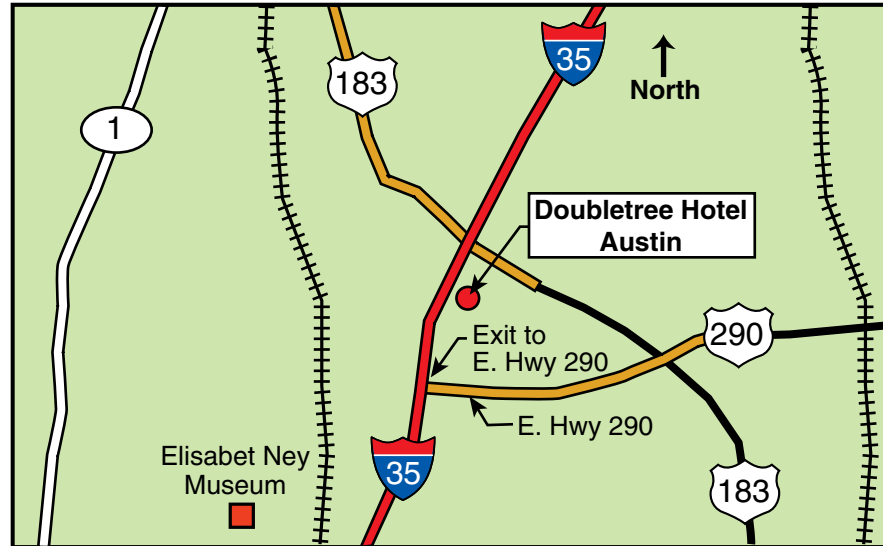

CRCPD to Pilot Tracking System for Machine-Based Radiation Medical Events

The Conference of Radiation Control Program Directors (CRCPD), a national nongovernmental professional organization dedicated to radiation protection, has identified medical radiation overexposures and misadministration as an important issue. Recent articles in the press, such as those in the following links, have brought medical events involving radiation machines to the public's attention:

However, for the past several years, CRCPD members had become concerned that such events should be reported, investigated, and tracked. The CRCPD's Suggested State Regulations for Control of Radiation Part X on Medical Therapy contains a provision that requires the reporting of therapy misadministrations. In addition, the feasibility of a national database of such events was discussed at the CRCPD Business Meeting during the May 2009 National Conference on Radiation Control.

Although the overall benefit and safety record for radiation therapy and other radiation procedures is quite high, errors in administration should be tracked for causes and trends. The CRCPD is in the process of staffing a committee to develop a pilot project to collect data on radiation machine-based events from state radiation control programs that will take into account states' differences in laws/regulations regarding reporting and confidentiality.

The charges of the Committee are as follows:

1. Develop a definition of reportable events to include radiation therapy using linear accelerators and e-brachytherapy technology, as well as high dose diagnostic procedures such as computed tomography (CT) and fluoroscopy.
2. Develop/maintain a format and mechanism for state programs to provide the committee with details of reportable events.
3. Review submitted reports for completeness and accuracy and develop notices to the state programs when necessary.
4. Oversee the development and maintenance of a CRCPD database of reportable events.
5. Prepare an annual summary report for the CRCPD Board and the *Newsbrief*.
6. Provide a verbal report at the Annual Meeting.

The data reporting will be done on a voluntary basis and will be used to inform and educate interested parties on trends, root causes, and methods for improvement.

Protection of Cesium Chloride Radiation Sources. Department of State Health Services (DSHS) Second Quarter 2010 Program Report to the Texas Radiation Advisory Board

May 1, 2010

General Program Information Radiation Safety Licensing Branch

The Nuclear Regulatory Commission (NRC) conducted its periodic audit of the radioactive materials program during the week of February 22. The audit, formally called the Integrated Materials Performance Evaluation Program (IMPEP), reviewed the five common performance indicators (technical staffing and training, status of materials inspection program, technical quality of inspections, technical quality of licensing actions, and technical quality of incident and allegation activities) as well as two non-common performance indicators (compatibility requirements and sealed source and device evaluation program). The draft finding by the review team is that the Texas Agreement State program is adequate to protect health and safety and compatible with the NRC's regulatory program. The NRC Management Review Board will review the team's findings and make a final determination on May 19, 2010. The department still is under a hiring freeze and a proposed five percent reduction in funding. Positions may only be posted for hiring after a justification is approved on a case-by-case basis.

Texas Commission on Environmental Quality Program Report to the Texas Radiation Advisory Board May 1, 2010, Meeting

Low-level radioactive waste disposal: on September 10, 2009, the executive director of the Texas Commission on Environmental Quality (TCEQ) signed and issued to Waste Control Specialists, LLC (WCS), the license that authorizes the near-surface disposal of Class A, B, and C low-level radioactive waste from the Texas Compact and federal facility mixed low-level radioactive waste from the federal government. There are several preconstruction conditions currently being reviewed by TCEQ under a pending amendment application and a requirement for TCEQ written approval prior to the commencement of major construction that is also currently under consideration. TCEQ staff met with the licensee and representatives of utility waste generators to discuss the rate application package, which will establish fees for the Texas Compact Facility. WCS was expected to file a rate application package with TCEQ in April 2010.

NRC Awards Nuclear Education Grants

The Nuclear Regulatory Commission (NRC) has awarded \$15 million to 59 institutions to boost nuclear education and expand the workforce in nuclear safety and nuclear-related disciplines. Congress provided NRC these funds for scholarships and fellowships, faculty development, trade schools, and community colleges, with \$5 million designated for NRC's part of the Integrated University Program. The Integrated University Program funds are coordinated and awarded through the NRC, Department of Energy, and National Nuclear Security Administration to support multi-year research projects that do not align with programmatic missions but are critical to maintaining nuclear engineering and science.

The NRC awarded 59 grants for scholarships (\$1.7 million), fellowships (\$4.8 million), faculty development (\$6.3 million), and trade and community college scholarships (\$2.2 million). Recipients are located in 29 states and Puerto Rico.

Grant proposals were reviewed against specific criteria by a panel composed of senior NRC staff and qualified outside reviewers. The panel composition was diverse with most reviewers having both experience reviewing proposals for government agencies and advanced credentials in nuclear engineering, health physics, radiochemistry, or related disciplines. Each panelist had to certify that they did not have any conflicts of interest for the proposals they evaluated.

timely, uniform, and adequate compensation for employees or their survivors who have suffered from illnesses incurred while working for the Department of Energy or its contractors.

“The Advisory Board on Radiation and Worker Health advises the Secretary of HHS about which employees at nuclear facilities can be considered for compensation in the event of radiation exposure and also oversees all aspects of

the compensation program,” Poston said. “Other members of the board include physicians, academics, labor representatives, representatives of nuclear engineering and health physics, as well as industrial hygienists and epidemiologists,” he added.

Poston has been at Texas A&M since 1985 and previously served as head of the Department of Nuclear Engineering.
